Course Description

No other issue ever dominated modern Middle East more than the Arab-Israeli conflict which has been shaping and reshaping the landscape, history, political developments of the region for over a century.

This course is a seminar-type for graduate and junior-senior undergraduate students of Political Science and Middle Eastern Studies. The course will cover the roots of the conflict from the birth of Zionism in Europe all the way to the peace process and conflicts of the late 20^{th} and early 21^{st} centuries.

Particular attention will be paid to the different narratives and discourse of all parties involved. Each student will select a country to act as its representative throughout the course. He/she will express the view of his/her particular government on topics under discussion. At the end of the course a round table peace conference will be held for half a day or two sessions in which students will table a peace plan and debate it throughout the session. Each student will be required to give a statement on behalf of the state he/she represents. The peace plan will be voted on and endorsed as the class vision of a just, durable and comprehensive peace.

Students are required to participate in the debate, follow certain blogs and websites, and follow the development in the areas under discussion on daily basis. A number of documentaries and films will be shown throughout the course.

Course Requirements

1- Class Attendance and Participation - 10%

Participation in the discussion is not only encouraged but also required. You are expected to read the assigned chapters or articles and come to class fully prepared to engage in the debate. Attendance will be checked each class and repeated absences will affect the final grade. Participation in activities related to the issues discussed in class will also be helpful. Students will be requested to give a brief presentation on topics under discussion.

- 2. Mid-term examination 30%
- 3. Conference simulation and position paper 20%

Students will be requested to write a position paper and make short presentations in the simulation conference. The debate will commence following the statements and a resolution will be tabled by group of countries. A final peace plan will be presented on behalf of the class to be communicated to the representatives of the countries concerned. It will be also published in local and regional press.

4. End of Term Take-Home Examination 40%

The examination will cover all topics discussed during the course. Make-up examinations are given in exceptional cases with the Dean's written approval.
